THIRTY -THIRD SUNDAY IN ORDINARY TIME

First Reading: Proverbs 31:10-13, 19-20, 30-31

An encomium for a good and worthy wife, this passage from Proverbs extols all the virtues which a worthy wife possesses – fidelity, industriousness, skill, charity to the poor, and fear of the Lord.

Second Reading: 1 Thessalonians 5:1-6

Once again, Paul reassures the Thessalonians, who are anxious about the coming of Christ, that they need not fear being unprepared because they are "children of light."

Gospel: Matthew 25:14-30

Jesus narrates the parable of the talents – in the story, the silver pieces given to the three men. Two of the men invest their coins and double their worth, but the third buries his coins in the ground and earns no return. The message of Jesus is that we must use to the fullest the talents we have received.

A FRESH PERSPECTIVE ON THE SUNDAY READINGS HIS WORD TODAY by Rev. William J. Reilly

Thirty-third Sunday in Ordinary Time November 15, 2020

"She reaches out her hands to the poor, and extends her arms to the needy. Charm is deceptive and beauty fleeting, the woman who fears the Lord is to be praised. Give her a reward for her labors, and let her works praise her at the city gates... Well done my good and faithful servant. Since you were faithful in small matters I will give you great responsibilities."

The proverbs of Solomon offer us the opportunity to reflect on gifts and virtues written so long ago, and yet are lived so well today. The value of a worthy one is beyond pearls.

Consider the heroic witnesses of Christ in our own country who established schools and orphanages, provided for the immigrant, the sick and children. Our history is written by Saint Elizabeth Ann Seton, Mother Catherine Drexel, Rose Duchense. Their ministry makes real the words of the old testament king.

Today, other outstanding witnesses mark our church. The four American churchwomen, martyred in El Salvador or Sister Dorothy Stang, murdered in Brazil, women committed to justice for the poor. Single mothers, working more than one job and raising their children are among our present day heroes who reflect values beyond pearls. The nurses and doctors sacrificing because of the virus, all serve not only in small matters but carry out great responsibilities. May we have courage to admire, praise and thank them.

The Church of Saint Dominic will remain open as a secondary worship site of Saints Peter and Paul Parish.



Notice Regarding Reporting Sexual Abuse of a Minor

It is the policy of the Diocese of Scranton to report any allegation of sexual abuse of a minor to law enforcement. If you are a victim of sexual abuse committed by a priest, deacon, religious or lay employee or volunteer of the Diocese of Scranton, you are encouraged to immediately report the matter to law enforcement. If any priest, deacon, religious, lay employee or volunteer of the Diocese of Scranton has cause or reason to suspect that a minor has been subjected to any form of abuse, including child sexual abuse, the matter will be reported to law enforcement. It is also the policy of the Diocese to adhere to all civil and state regulations. In accordance with the Commonwealth of Pennsylvania's Child Protective Laws, reports of suspected child abuse should also be made immediately by phone to the 24 hour Child Abuse hotline (Childline) at 1-800-932-0313 or electronically at www.compass.state.pa.us/cwis. To this end, the Diocese is equally committed to adhering to the norms of the Code of Canon Law and to upholding the tenets of the USCCB Charter for the Protection of Children and Young People, which includes supporting victims of sexual abuse in their pursuit of emotional and spiritual well being. As such, information regarding an allegation of sexual abuse of a minor should also be reported to the Victim Assistance Coordinator, Mary Beth Pacuska at 570-862-7551

Seeing a Future Full of Hope

SHAPING A BLUEPRINT FOR THE FUTURE OF THE DIOCESE

In Today's homily for the Second Sunday of Advent, Bishop Bambera explained to us that it is time for the whole Church of Scranton to take a good look at the life of our parishes and to project a future vision in response to God's call today.

Your Pastors have taken first steps in this conversation in recent deanery meetings, and now it is essential to broaden this conversation to include all of the faithful. Bishop Bambera Pointed out to us the reality of change in our world and in our local communities, and so we know that we will continue to face and respond to change within the church. "I'm inviting all of the faithful," he said, "to simply focus on how we best engage the mission of the gospel in these changing times." Some of these changes include shifting demographics, differing attitudes about formal church participation, and diminishment in numbers of ordained priests available to serve as full-time pastors.

In the coming year, then, Bishop Bambera is asking us to continue working together to fashion a "blueprint" if you will— a pathway for our ocal Church, tailored to each deanery and to each parish—for how we will meet both the challenges and opportunities we will face in the next ten year period.

In his Homily he stressed that, "while every parish is similar in what is being asked to do and to be, each parish will respond to this process in ways that are unique to its situation and circumstances.

PLANNING GUIDANCE FOR EACH DEANERY

Guiding the overall process are these planning assumptions as common elements across the Diocese:

- The benchmarks for vibrant parishes are in accord with the vision expressed in Bishop Bambera's Pastoral letter, especially pages 7-13
- In every local circumstances, efforts are made to best utilize the particular ministry gifts of the clergy and, at the same time, to mobilize the gifts of all the baptized.
- Each deanery blueprint implementation is unique, and may consider such questions as: number of worship sites, Mass schedules and wise investment of resources.
- No deanery is planning in isolation—the circumstances in one may occasion change in another.
- Parish pastoral plans are respected and help to inform deanery level plans.
- Recommendations from deaneries or parishes are brought to Diocesan review.
- Parishes in linked relationship, sharing a Pastor, will be given additional planning support to evaluate and craft the best path forward.
- Every parish calls forth those individuals whose capacity for pastoral leadership could be developed through vocational discernment for priesthood, religious life, lay ministry or permanent diaconate.

Diocese of Scranton adds eight names to list of credibly accused individuals

The Diocese of Scranton announces that eight additional names have been added to its list of individuals who have been credibly accused of sexual abuse of a minor.

Bishop Joseph C. Bambera has consistently asserted that the abuse of minors cannot be tolerated. In maintaining his and the Diocese of Scranton's commitment to protect children and young people, the Bishop stated that it is his hope that the publication of these additional names will be a step forward in the healing process for survivors.

In August 2018, the Diocese published on its website a list of all clergy, staff and volunteers who had been credibly accused of child sexual abuse. Since that time, eleven additional names were added to the list in January 2019 and two more names were added in October 2019. The most recent additions to the list involve allegations of abuse submitted to the Independent Survivors Compensation Program (ISCP).

The Diocese assesses the credibility of allegations of abuse utilizing a process that includes, as appropriate, assessments by outside counsel and investigation by a former FBI agent. In addition, the Diocesan Review Board, an independent, consultative body comprised of members of the laity, a religious sister and one priest, performs a case-by-case review. The Diocese also takes into account the determination by the Administrators of the ISCP, for allegations that were submitted in that program. All allegations are submitted to the appropriate District Attorney's Office. Allegations that are corroborated by secular legal proceedings, canon law proceedings, admission by the accused, and/or other information or evidence are deemed credible.

All but one of the Diocesan Clergy listed above are deceased. The sole living credibly accused clergy, Monsignor Joseph P. Kelly, entered into retirement prior to the conclusion of the Independent Survivors Compensation Program. After notification of multiple allegations received through the ISCP, the Diocese of Scranton enacted the *Essential Norms* of the Charter for the Protection of Children and Young People and placed Monsignor Kelly on administrative leave, prohibiting his ability to publicly celebrate the sacraments or present himself as a priest.

The Diocese of Scranton urges any individual who has been sexually abused by a priest, deacon, religious, lay employee or volunteer of the Diocese to report abuse directly to law enforcement. Report on the Independent Survivors Compensation Program in the Diocese of Scranton

October 29, 2020

INTRODUCTION

On January 22, 2019, the Diocese of Scranton launched its Independent Survivors Compensation Program (ISCP) to promote healing and recovery for survivors of clergy sexual abuse. The Program was purely voluntary and open to individuals who had submitted a complaint of sexual abuse to the diocese before the Program was first announced as well as individuals who had not previously submitted a complaint.

Survivors of abuse committed by Diocese of Scranton priests, members of religious communities and by lay employees of the diocese were able to submit claims. The Program confronted a dark and difficult chapter in the history of the Church. The diocese created the ISCP in order to publicly recognize the harm caused to survivors of abuse, demonstrate the Church's commitment to those survivors and hopefully to provide validation and a measure of healing.

HOW DID THE ISCP WORK?

The ISCP has been completely independent from the Diocese of Scranton. Kenneth Feinberg and Camille Biros, two nationally recognized claims administration experts, administered the ISCP. Their prior experience involved handling the September 11th Victim Compensation Fund, BP Deepwater Horizon Disaster Victim Compensation Fund and similar compensation Programs for numerous other Catholic dioceses.

In addition, the Program has been monitored by an Independent Oversight Committee comprised of Robert Gillespie, Jr., former Luzerne County District Attorney, Ralph H. Meyer, President and Chief Executive Officer Emeritus with Guthrie Healthcare System and Robin Engels, MA, MSW, LCSW, a licensed clinical social worker.

The Program administrators retained complete and sole discretion over eligibility and compensation offers to eligible survivors who participated in the Program. The Diocese of Scranton could not reject any of the administrators' final determinations regarding eligibility and/or compensation.

Serving as independent administrators, Mr. Feinberg and Ms. Biros worked with individuals who had previously submitted a complaint of sexual abuse to the diocese. These individuals were invited by letter to participate in the Program.

Individuals who had not previously filed a complaint with the diocese could register to participate in the Program through a website that was established. New complaints of abuse received through the Program must also have been reported to the appropriate District Attorney's Office.

Individuals were invited to provide any documentation and corroborating information to substantiate the claim. This information aided administrators in making fair and accurate determinations. Claims were handled in the order in which they were received and administrators used information submitted to process and pay claims. One of the most important aspects of the Program was its confidentiality.

RESULTS OF THE ISCP

Total claims submitted: 295 Claims determined ineligible: 46

Total eligible claims: 249
Offers that remain outstanding: 25
Rejected offers: 11

Total claims paid: 213

Total paid to claimants: \$24,460,000

The Administrators have processed all claims and have sent determination letters to the claimants. More than 85% of claimants accepted their offers and less than 5% rejected their offers. Under 10% of the claims remain outstanding. The diocese anticipates that these outstanding claims will be resolved in the near future.

Before accepting compensation through the ISCP, all individuals were required to consult with an attorney for the purpose of reviewing documents and understanding agreement language. If the claimant did not have an attorney, the administrators provided an independent attorney for consultation free of charge. By choosing to accept the offered compensation, the individual waives any future legal claim against the Diocese of Scranton related to their sexual abuse claims.

HOW WAS THE ISCP FUNDED?

The Program was primarily funded by the sale proceeds of the Diocese of Scranton's three long-term care facilities in 2019, which was planned long before the ISCP was created. The Diocese received approximately \$26 million from the sale of the properties and subsequent transfer of

assets held by these three facilities. In addition, some funding for the Program was provided by Diocese of Scranton insurers and contributions from other religious orders.

The diocese did not use any funds that had been given by the faithful to support parishes, schools, the Diocesan Annual Appeal, Catholic Social Services of the Diocese of Scranton or any donor-restricted contributions.

DIOCES AN RESPONSE TO CLERGY CHILD SEXUAL ABUSE

The Diocese of Scranton maintains a zero tolerance policy for clergy, lay employees and volunteers who engage in misconduct with minors and takes immediate action when an accusation is made. Any allegation of abuse is reported immediately to law enforcement and any substantiated allegation against a member of the clergy results in immediate and permanent removal from ministry.

The Diocese of Scranton formally established a "Policy Concerning Clerics Accused of Sexual Abuse of Minors" in March 1993. When the bishops of the United States Conference of Catholic Bishops adopted a comprehensive plan on this issue in 2002, the Diocese refined and expanded its procedures. After prayerful reflection, extensive research and study, and purposeful review by several external and internal entities, including the Diocesan Review Board, the most recent policy, the *Diocese of Scranton Policy for Response to Allegations of Sexual Abuse of Minors*, took effect in 2015. A copy of the policy is provided to all members of the clergy and seminarians. The policy is made available to all diocesan employees and members of the general public on the diocesan website.

The Diocese of Scranton continues to address this serious issue with vigilance and fidelity so that its policies, procedures and practices achieve genuine transparency and true accountability. The Diocese's Safe Environment Program has a multi-faceted approach, including:

- Background Checks Ensuring a thorough background screening is completed for all clergy, paid employees and volunteers that have direct contact and routine interaction with children.
- Adult and Youth Training Providing training, prevention and educational programs
 in recognizing and reporting any suspicions or knowledge of child abuse to appropriate
 civil and Church authorities. As of October 2020, more than 31,340 individuals have
 completed VIRTUS training since 2003.
- Code of Pastoral Conduct A document holding all clergy, employees and volunteers
 accountable to a Christ-centered, pastoral code of conduct.
- Office of Victim Assistance The role of the Victim Assistance Coordinator is to
 facilitate the immediate pastoral care of persons that claim to have been sexually abused
 by a cleric when they were minors. The Victim Assistance Coordinator provides support
 and services, including arranging for counseling or spiritual direction and referrals to
 support groups.

Diocesan Review Board - An independent, consultative body comprised of members of
the laity, a religious sister and one priest, which performs a case-by-case review of
allegations of sexual abuse of a minor, reviews diocesan policies for responding to the
accusation of sexual abuse of a minor by Church personnel and advises the bishop in his
determination of suitability for ministry of the accused.

The Diocese has passed independent audits of its child protection procedures every year since the policy was adopted by the United States Conference of Catholic Bishops in 2002. The audit evaluates each diocese's efforts to ensure the protection of children.

CONCLUSION

The Independent Survivors Compensation Program fulfills two promises made by Bishop Joseph C. Bambera. First, to promote the healing and recovery of survivors. Second, to directly confront a scandal that robbed many of the most vulnerable of their innocence and peace. While nothing can take away their pain, several survivors have commented that their participation in the Program has provided a measure of solace and an opportunity to move forward. Many survivors have also expressed an appreciation for the privacy that the Program provided.

The Diocese of Scranton continues to urge any individual who has been sexually abused by a priest, deacon, religious, lay employee or volunteer of the Diocese to report abuse directly to law enforcement or the Diocese's Victim Assistance Coordinator.

While the Program has concluded, the Diocese's outreach to survivors of clergy sexual abuse continues. The Diocese of Scranton is committed to learning from the mistakes of the past and moving forward with renewed resolve to protect all children from abuse.
